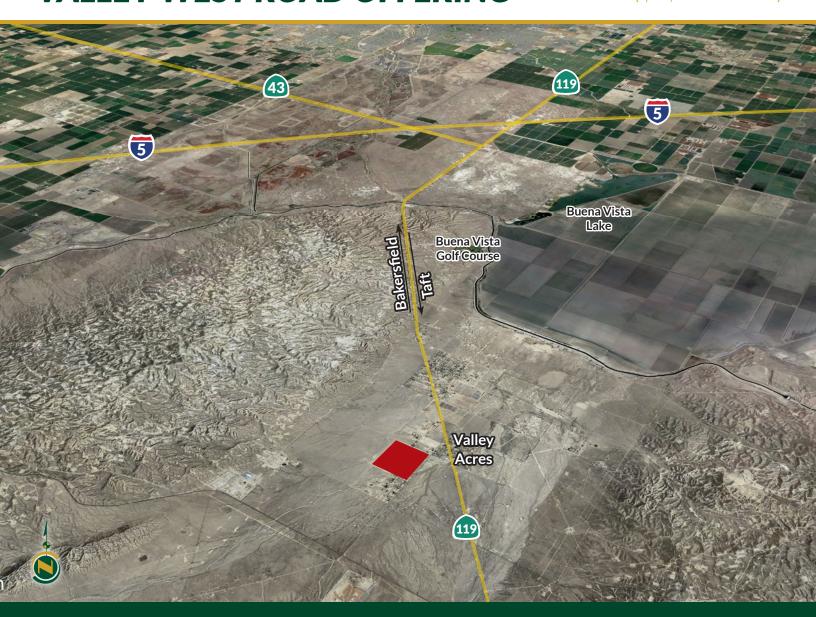

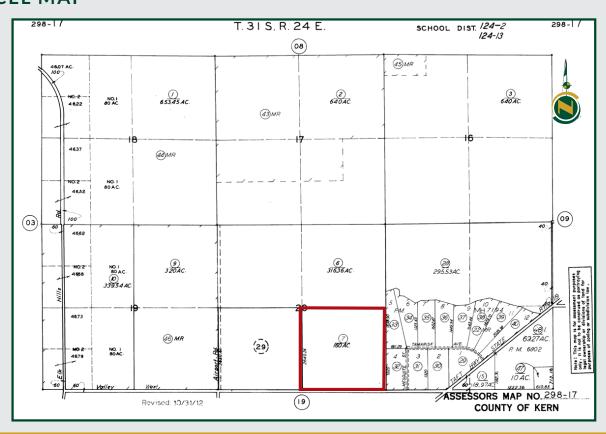

PARCEL MAP

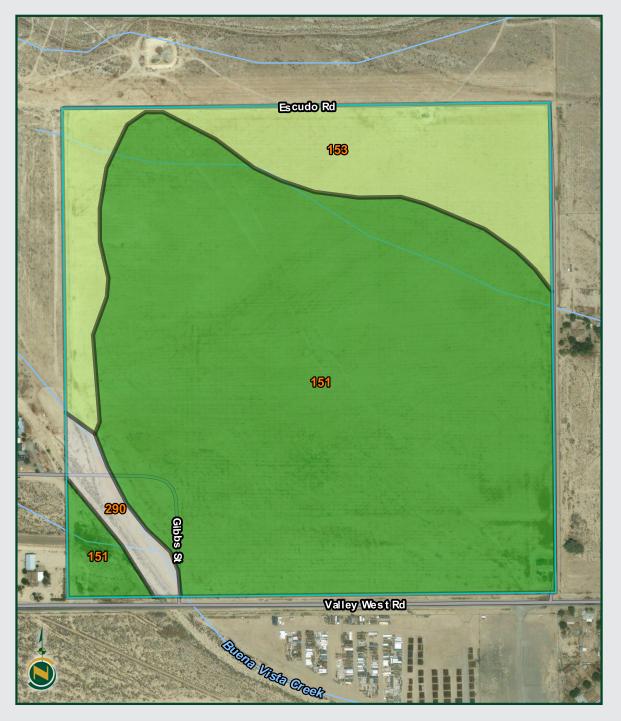
