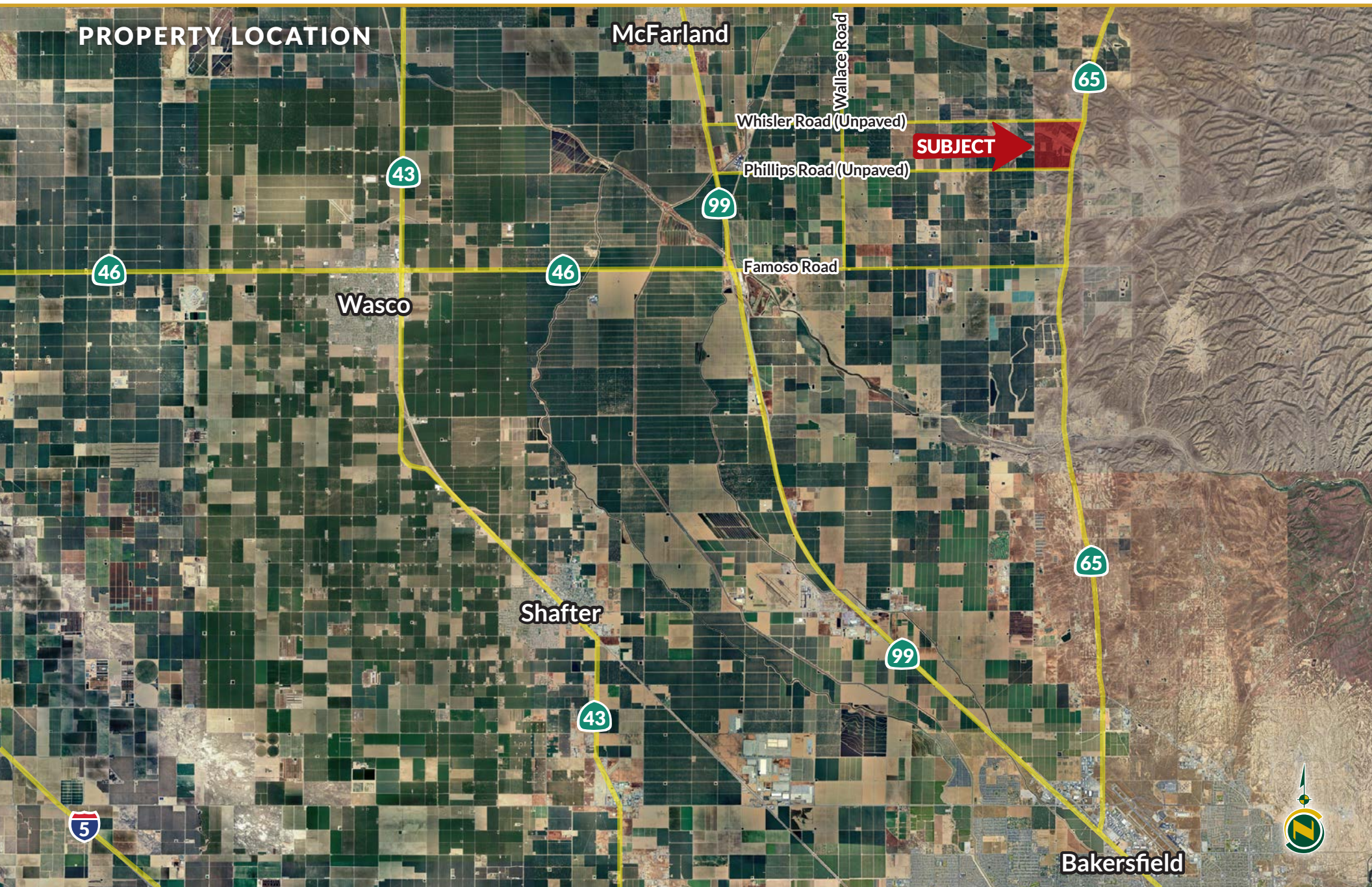

PROPERTY INFORMATION

LOCATION

The property is located on the west side of Highway 65, approximately one mile south of Sherwood Avenue and two miles north of Famoso Road in northeast Kern County. The City of Bakersfield is 10± miles to the south of the entrance.

DESCRIPTION

This organic ranch consists of 557.05± acres and is planted to numerous varieties of citrus, with majority of the ranch planted to Navels, followed by lemons, grapefruit and specialty Cara Cara Red Navels and Blood oranges. The irrigation system consists of two Ag wells and Cawelo Water District supplying surface water. The property is in the Cawelo Water District GSA.

The land is zoned A (Exclusive Agricultural) by Kern County.

BUILDINGS

1,000± square foot shop with two roll-up doors, fully contained within chain link fencing with an accessible area for equipment storage and maintenance.

WATER

Irrigation system consists of two Ag wells. One well is operated by a 500HP diesel motor and gear head and the second well is an above ground 150HP electric motor. Water is pumped from the reservoir through a sand media filtration system to the micro jet sprinkler system.

Property lies within the Cawelo Water District GSA. Cawelo Water District provides water from Turnout #C-25 to the reservoir. The yearly dry standby charge from Cawelo WD is \$282 per acre, the 2024 estimated price per acre foot of water from Cawelo WD is \$274.42 an AF. The special assessment for calendar year 2023 from Cawelo Water District was \$52,919.75 (\$95 per acre).

\$16,711,500 (\$30,000 per acre) All cash at close of escrow. Buyer to reimburse seller for cultural costs incurred towards the 2024/2025 citrus crop.

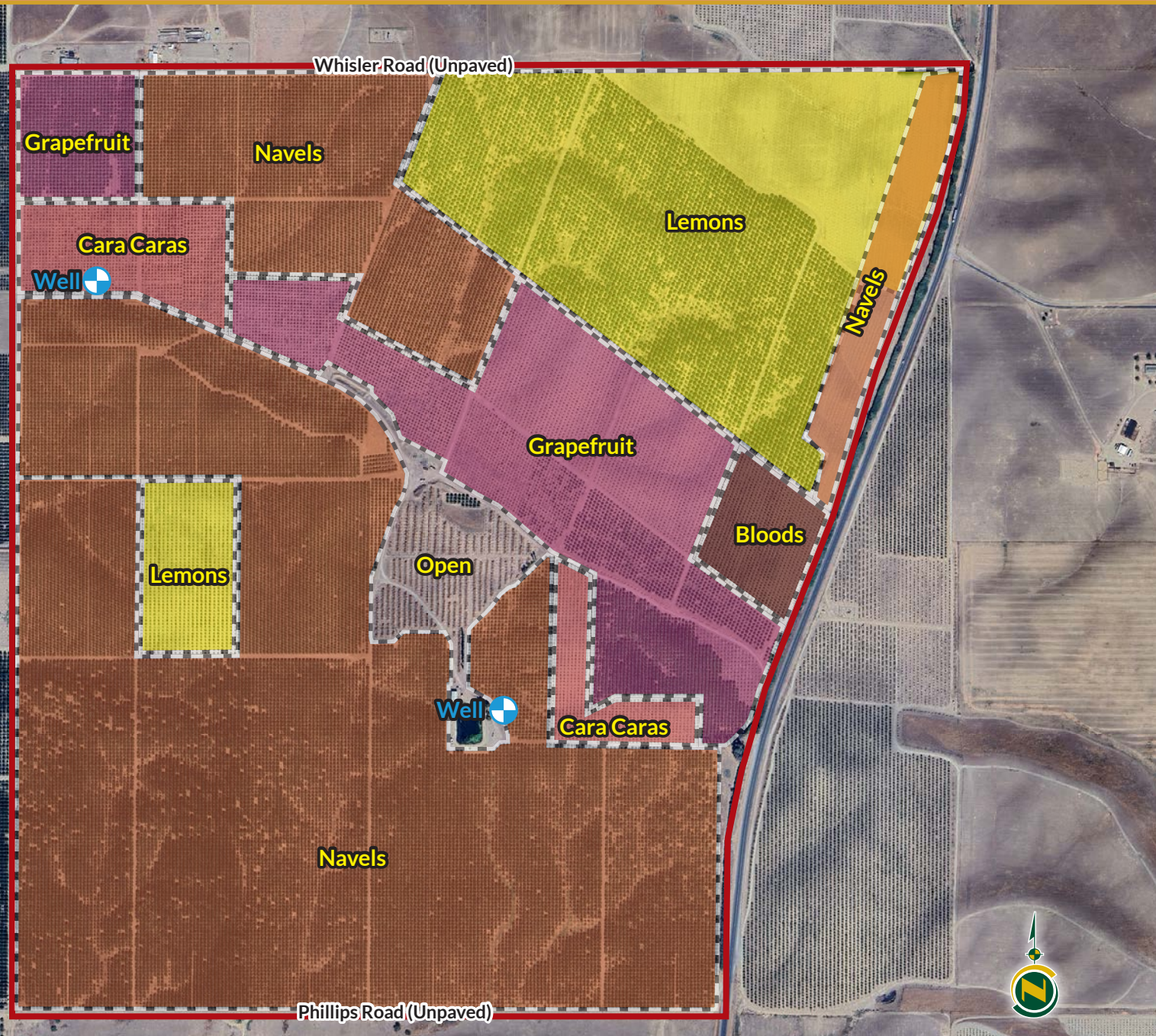

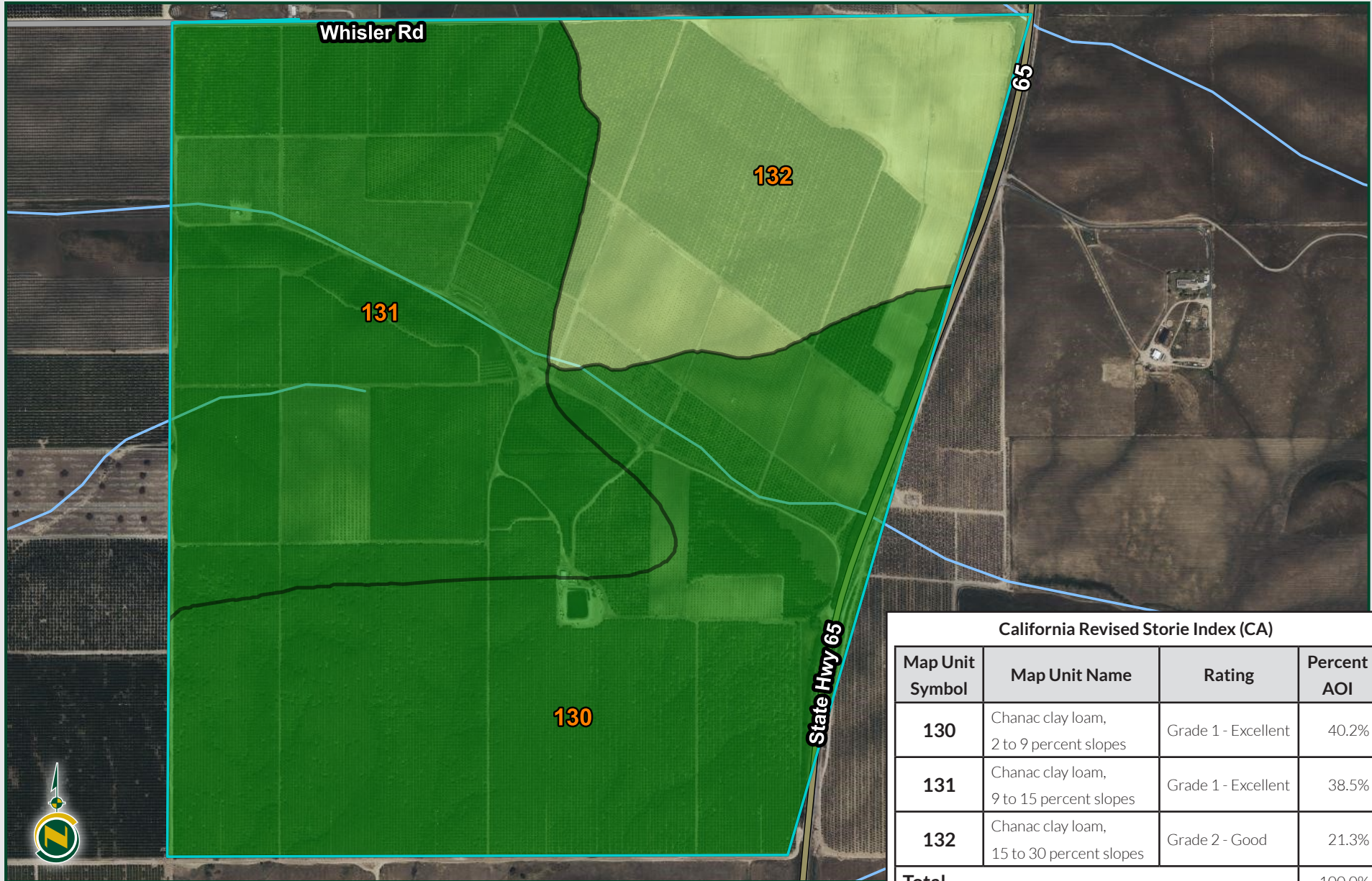

SOILS MAP



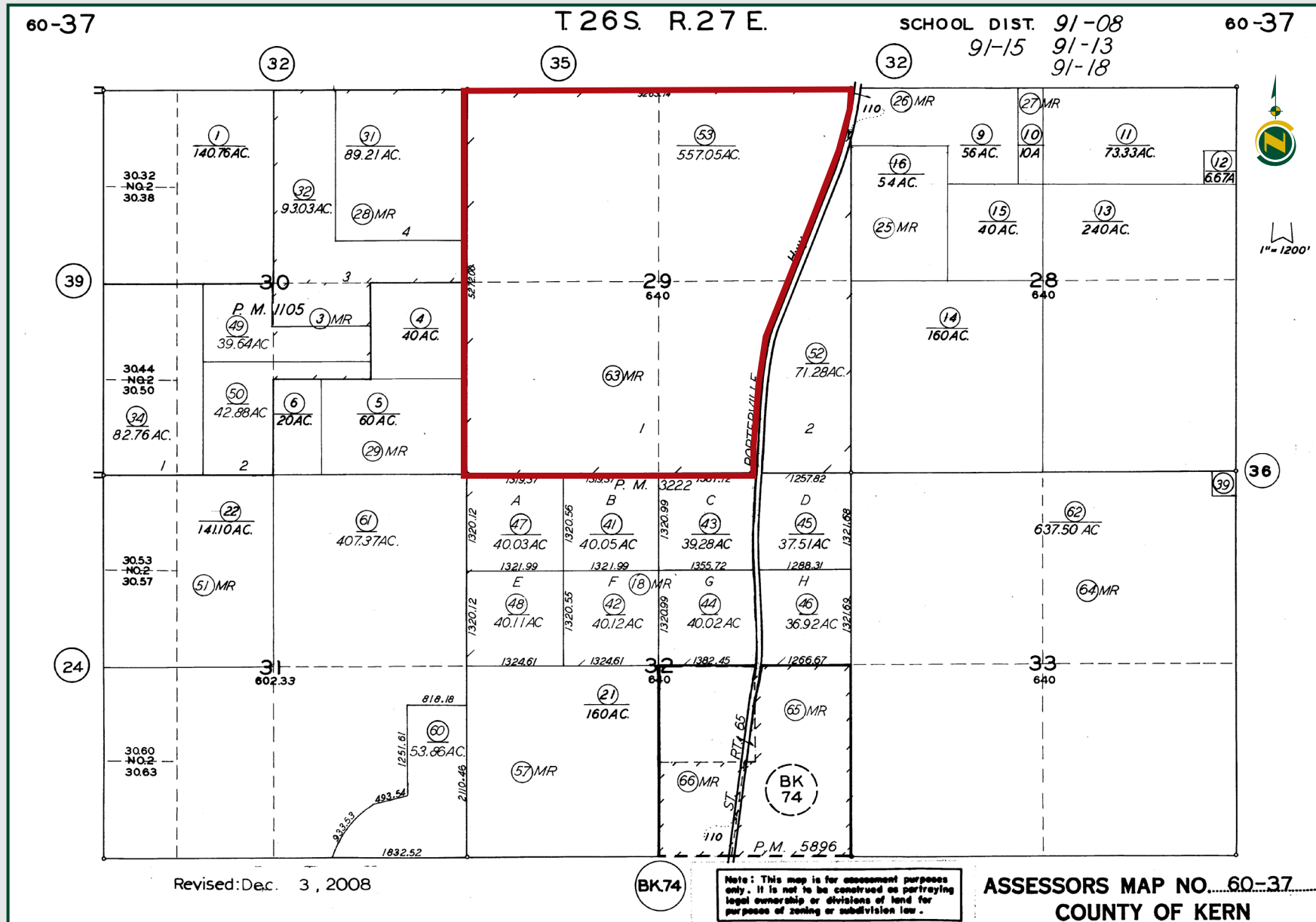
